

Resolution No. 2770

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2018 and ending September 30, 2019; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2018 and terminating on September 30, 2019 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption of Budget Amendment.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2018 and terminating on September 30, 2019 is hereby revised and amended by Attachment "A". The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2018 and

terminating on September 30, 2019 shall remain in full force and effect.

Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.


Section 6. Effective Date.

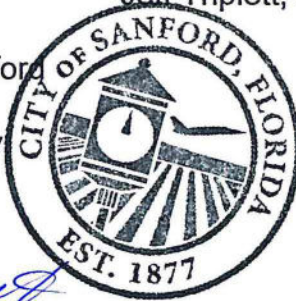

Two of the bids are below the Engineer's Estimate which was \$1.27 million (without contingency). Note: due to the over \$200,000 difference from Cathcart's bid to the next lowest bid, we contacted Cathcart. They confirmed that they stand by their submitted bid and that there are no mistakes in the submitted bid pricing.

We have reviewed Cathcart Construction Company-Florida LLC ("Cathcart") in terms of their storm and utility construction experience, recent references, and licensing. Financial information the City received from Cathcart (Financial Information Form - Section 00462 plus attachments) has not been reviewed by CPH and should be reviewed by the City. If the City requires audited financial statements in lieu of what was provided, please let us know or contact Cathcart directly.

Cathcart is located in Oviedo and has been in business since 1994; however, in 2014 they re-organized under the current LLC. Our review of projects and references is based on the current iteration of Cathcart. Since 2014, Cathcart has performed construction on numerous projects similar in type and size (or bigger) than the proposed Downtown Storm and Utility Relocations project. Most of Cathcart's construction projects were for various municipalities and counties. We have contacted several references for Cathcart: the references contacted (the cities of St. Cloud, Orlando, and Altamonte Springs) were very satisfied with the work done by Cathcart and all indicated they would work with Cathcart again. The project manager and superintendents named by the references received favorable comments and are the same

SYNOPSIS:

Award of Bid # IFB18/19-01 to the lowest responsive and responsible bidder is proposed for the Downtown Storm and Utility Relocations and approval of implementing procurement activity is requested. A Budget Amendment Resolution has also been attached amending the Stormwater portion of the project funding.

FISCAL/STAFFING STATEMENT:

The total amount requested is an amount not to exceed \$1,036,914.50 and is available from Utilities and Stormwater account lines.

BACKGROUND:

The City of Sanford plans to redevelop the area of Downtown between Palmetto Avenue and Sanford Avenue which is situated between First Street and Seminole Boulevard. It necessary to relocate the existing aging water, sanitary sewer and stormwater infrastructure (most of which are over 100 years old). The relocated utilities will allow for broader commercial development by unifying the Downtown with the Riverwalk and Waterfront. The City advertised an Invitation for Bid in accordance with City Procurement Policies. The project was competitively bid with Cathcart Construction Company-Florida, LLC of Oviedo, Florida submitting the lowest and most responsive bid as determined by City staff.

LEGAL REVIEW:

The City Attorney has reviewed and has no legal objection to the actions to be implemented in accordance with City Purchasing Policy.

RECOMMENDATION:

It is staff's recommendation that the City Commission award Bid #IFB 18/19-01 to Cathcart Construction Company-Florida, LLC and approve the implementing procurement activities in an amount not to exceed \$1,036,914.50.
